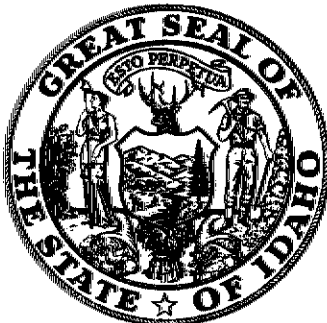

# ARTICLES OF INCORPORATION

OF

COLPRON AND ASSOCIATES, INC.

The undersigned, a natural person acting as an incorporator in order to form a corporation (hereinafter "Corporation") under the provisions of the Idaho Business Corporation Act, Idaho Code Section 30-1-1 et seq., (the "Act"), adopts the following Articles of Incorporation:

## ARTICLE I. NAME

The name of the Corporation is COLPRON AND ASSOCIATES, INC.

## ARTICLE II. DURATION

The Corporation shall have perpetual duration.

## ARTICLE III. PURPOSE

The purpose for which the Corporation is organized is to transact all lawful business for which corporations may be organized under the Act.

## ARTICLE IV. REGISTERED OFFICE AND AGENT

The location and street address of the initial registered office of the Corporation is 2399 South Orchard Street, Suite 208-A, Boise, Idaho 83705. The initial registered agent of the Corporation shall be Merlyn D. Colpron whose address is located at 2399 South Orchard Street, Suite 208-A, Boise, Idaho 83705.

## ARTICLE V. AUTHORIZED SHARES

SECTION 1. NUMBER. The aggregate number of shares which the Corporation shall have the authority to issue is One Thousand

(1,000) shares of voting common stock of \$1.00 par value.

SECTION 2. DIVIDENDS. The holders of the common stock shall be entitled to receive, when and as declared by the Board of Directors, as permitted by the Act, dividends or distributions payable in cash, in property, or in shares of the capital stock of the Corporation.

SECTION 3. VOTING POWER. The entire voting power for the election of the Directors and for all other purposes shall be vested exclusively in the holders of the common stock, who shall be entitled to one vote for each share of common stock held by them of record.

#### ARTICLE VI. INITIAL BOARD OF DIRECTORS

The initial Board of Directors and the names and addresses of the persons who shall serve as Directors until the first annual meeting of Stockholders or until their successors be elected and qualified are:

#### ARTICLE VII. RESTRICTION ON TRANSFER OF SHARES

The transfer of the shares of the Corporation are subject to restriction as more particularly described in the bylaws of the Corporation. The restriction shall be noted conspicuously on the face of all share certificates.


ARTICLE VIII. PREEMPTIVE RIGHTS
