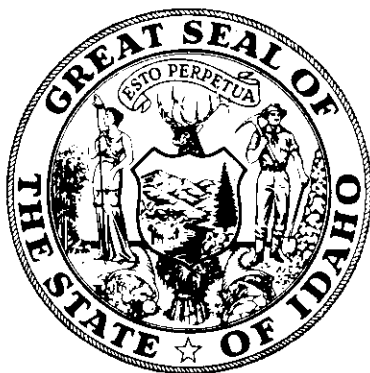

ARTICLES OF INCORPORATION
SUN VALLEY WILDERNESS OUTFITTERS, INC.

The undersigned, acting as the incorporator under the provisions of the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

1. NAME. The name of the corporation is: SUN VALLEY WILDERNESS OUTFITTERS, INC.
2. DURATION. The period of its duration is perpetual.
3. PURPOSES. The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, including, but not limited to, the running and operating of a guiding and outfitting service.
4. STOCK. The corporation shall have the authority to issue FIFTY THOUSAND (50,000) shares of capital stock, all of one (1) class, and ONE & 00/100 DOLLAR (\$1.00) par value.


