If you do not wish to formally dissolve the corporation, you may allow it to forfeit its right to do business by failing to file an annual report for the corporation. If an annual report is not filed, the corporation will forfeit its right to do business on December 1, 1995 and be dissolved by operation of law on March 1, 1996.
