ARTICLES OF INCORPORATION

OF

EXPRESS TYPOGRAPHICS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is EXPRESS TYPOGRAPHICS, INC.

SECOND: The period of the corporation's duration is perpetual.

THIRD: The purposes for which the corporation is organized are: the providing of typesetting and graphic services and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one hundred (100) shares of common stock. All of such shares are to be without par value.

FIFTH: Provisions denying preemptive rights are: none.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are set forth in the by-laws of the corporation.

SEVENTH: The address of the initial registered office of the corporation is 220 Lewis Street, Ketchum, Idaho, Post Office Box 16, Ketchum, Idaho 83340, and the name of its initial registered agent at such address is Carolyn Dwyer.

EIGHTH: The number of directors constituting the initial board of directors of the corporation is two (2), and the names and addresses of the persons who are to serve




