## ARTICLES OF INCORPORATION

The undersigned, acting to incorporate a corporation under the SEC. OF STATE

Idaho Business Corporation Act, adopt the following Articles of 91 AUG 1 AUG 1

- 1. NAME: The name of the corporation is BLA Advisors, Inc..
- 2. DURATION: The period of its duration is perpetual.
- 3. PURPOSES: This corporation may transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
- 4. SHARES AUTHORIZED: The aggregate number of shares which the corporation shall have authority to issue is ten thousand (10,000) shares at \$ 1.00 par value common stock.
