ARTICLES OF INCORPORATION

Effective as of June 30, 2003 (the "**Effective Date**"), the Articles of Incorporation of KiB, Inc. are in their entirety as follows:

Article 1 NAME OF THE CORPORATION

The name of the corporation is KiB, Inc. (the "Corporation").

Article 2 PURPOSES OF THE CORPORATION

The purposes for which the Corporation is organized is: (i) to own and/or operate gyms and any, every and all aspects entailed therein, including but not limited to associated retail sales,; (ii) to train and consult for athletic trainers and (iii) to do any and all other lawful activities.

Article 3 SHARES

- **3.1 Stock.** The aggregate number of shares the Corporation is authorized to issue shall be 1,000 common shares with no par value of voting stock (the "**Common Stock**").
- 3.2 Transfer. No shareholder of the Corporation may sell or transfer shares except to another individual who is eligible to be a shareholder of the Corporation. Sale or transfer may be made only after the sale or transfer has been approved at a shareholders' meeting especially called for the purpose of approving the sale or transfer of Common Stock. At the special meeting, 75% of the outstanding stock of the Corporation must approve the sale or transfer of Common Stock.
- 3.3 Treasury Shares. Unless a resolution of the Board of Directors provides that reacquired shares shall constitute authorized but unissued shares, any shares reacquired by the Corporation shall be Treasury Shares and may be held, used, resold, or disposed of free of any restrictions that would be imposed on the original issuance of shares of the Corporation.

Article 4 PREEMPTIVE RIGHTS

Shareholders of the Corporation shall have no preemptive rights to acquire stock in the Corporation.

Article 5 CUMULATIVE VOTING

Shareholders of the Corporation do not have the right to cumulate their votes for Board of Directors.

Article 6 NOTICE OF MEETINGS AND VOTING

- **6.1 Notice.** Written notice of meetings shall be delivered to all shareholders of the Corporation. Notice of meetings shall be given pursuant to the Bylaws of the Corporation.
- **6.2 Voting.** Each outstanding share of stock shall be entitled to one (1) vote on each matter submitted to a vote at a meeting of shareholders, including election of directors of the Corporation and other corporate purposes.

Article 7 REGISTERED OFFICE AND AGENT

The address of the registered office of the Corporation is 2108 Caldwell Boulevard, Suite #3, Nampa, Idaho 83651, and the name of the registered agent at such address is Pete Johanson.

Article 8 BOARD OF DIRECTORS

Article 10 LIMITATION OF LIABILITY
