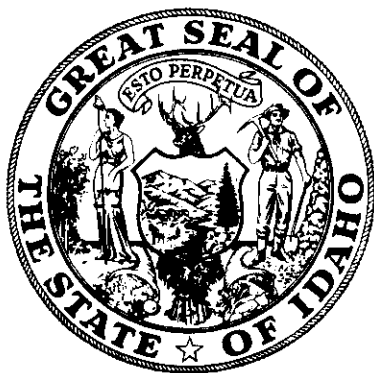

ARTICLES OF INCORPORATION

FULTON & LIGHTY, INC.

The undersigned acting as incorporators of a corporation under the Idaho Business Corporation Act adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

The name of the corporation is FULTON & LIGHTY, INC.

ARTICLE II.

The duration of this corporation shall be perpetual.

ARTICLE III.

The purposes of this corporation are to own, manage and operate a wood products manufacturing plant, to purchase and sell wood products, and to further engage in any commercial, industrial and agricultural enterprises calculated or designed to be profitable to this corporation.

ARTICLE IV.

The total number of shares of common stock which the corporation shall have authority to issue is 100 which shall be without par value. All stock shall be non-assessable.

ARTICLE V.

The holders from time to time of the common stock of the corporation shall have the pre-emptive right to purchase, at such respective equitable prices, terms and conditions as should be fixed by the board of directors, such of the shares of the corporation that may be held in the treasury of the corporation, or as may be authorized from time to time over and above 100 shares of common stock authorized by the original Articles of Incorporation of the corporation. Such pre-emptive rights shall be exercised in the respective ratio which the number of shares held by each shareholder at the time of such issue bears to the total number of shares outstanding in the names of all shareholders at such time.

ARTICLE VI.

The location and post office of the registered office of the corporation is on Old Highway 95 north of Hayden Lake, Idaho. The name of the registered agent is Roger K. Lighty.

ARTICLE VII.

The number of directors of this corporation shall be two. The names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are as follows:
