ARTICLES OF INCORPORATION.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are citizens and residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho, and,

WE HEREBY CERTIFY,

1st: That the name of said corporation shall be, Jefferson Irrigation Company, Limited.

2nd: That the purposes for which it is formed are;

(a) The purchasing, acquiring, holding, selling and otherwise disposing of water, water rights, rights-of-way for ditches, canals, reservoirs, dams and real and personal property, stocks, bonds, notes, and other securities;

(b) Purchasing acquiring, constructing, repairing, selling, and otherwise disposing of dams, reservoirs, canals, ditches and rights-of-way for same;

(c) The owning, controlling, diverting and distributing of water through the irrigation works belonging to the corporation to the stockholders thereof, and the renting of surplus water owned and controlled by this corporation;

(d) Levying and collecting assessments, fixing and collecting rentals, maintenance charges, and doing all other things (not inconsistent with the laws of the State of Idaho) necessary to the full and complete operation, management, control, and welfare of the corporation.

3rd: That the place where the principal business of said corporation is to be transacted is Roberts, Fremont County, State of Idaho.

4th: That the term for which said corporation is to exist is fifty years from and after the date of its incorporation.

5th: That the number of directors of said corporation

shall be five, and that the names and residences of the directors who are appointed for the first year, and to serve until the election and qualification of their successors are as follows, to-wit;

6th: That the amount of the capital stock of the said corporation is Thirty Thousand Dollars (\$30,000.00) and the number of shares into which it is divided Thirty Thousand (\$30,000) of the par value of one dollar each.

7th: That the amount of said capital stock which has been actually subscribed is Two Thousand Dollars (\$2,000.00), and the following are the names of the persons by whom the same has been subscribed and the amount subscribed by each, to-wit:
