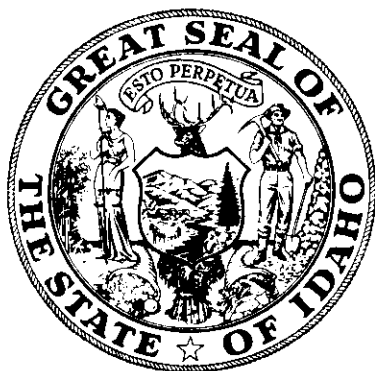

ARTICLES OF INCORPORATION
OF
KUHLMAN BROTHERS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is KUHLMAN BROTHERS, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, including but not limited to logging and all business related to the operation of buying, selling, cutting and harvesting timber.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 50,000 shares of the par value of \$ 1.00.

FIFTH: Provisions denying preemptive rights are: None.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: None:

SEVENTH: The address of the initial registered office of the corporation is 104 Park Lane, Post Falls, Idaho, and the name of its registered agent at such address is Melvin E. Kuhlman.


