



KNOW ALL MEN BY THESE PRESENTS:

The undersigned, natural persons of the age of twentyone years or more, acting as incorporators of a corporation under
the Montana Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I.

The name of the corporation shall be:

LBM EQUIPMENT SUPPLY CO.

ARTICLE II.

The period of its duration is perpetual.

ARTICLE III.

The purposes for which the corporation is organized are:

- a) To carry on the business of buying, selling, renting, leasing, consigning and dealing in and with restaurant fixtures, supplies, equipment and accessories;
- b) To purchase, lease, option or otherwise acquire, and to sell, exchange or otherwise dispose of, and pledge, mortgage and deal in and with restaurant fixtures, supplies, equipment and accessories;
- c) To do everything, as principal or agent, singly or in association with others, which may be necessary, proper or convenient for the accomplishment of the purposes herein set forth, and to engage in any other business so long as the same is not forbidden by law.

ARTICLE IV.

The aggregate number of shares which the corporation shall have authority to issue is 50,000 shares of common capital stock, without par value.

ARTICLE V.

The address of the initial registered office of the corporation is 2401 Montana Ave., Billings, Montana, and the name of its initial registered agent at such address is Roger L. Howell.

ARTICLE VI.

The number of directors shall be not less than three, but subject to such limitation, the number of directors shall be fixed by the By-Laws and may be increased or decreased from time to time by amendment to the By-Laws, but no decrease shall have the effect of shortening the term of any incumbent director. The number of directors constituting the initial Board of Directors of the corporation is three, and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders, or until their successors are elected and qualified, are:
