

ARTICLES OF AMENDMENT

TO THE

ARTICLES OF INCORPORATION

OF

NOAC, INC.

Pursuant to the provisions of Section 30-3-89 of the Idaho Non-Profit Corporation Act, the undersigned non-profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is NOAC, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the members of the corporation on the <u>Alst</u> day of <u>August</u>, 1997, in the manner prescribed by the Idaho Non-Profit Corporation Act:

To ARTICLE V. PURPOSES. is added the following: charitable, religious, educational or scientific within the meaning of Section 501(c)3 of the Internal Revenue Code of 1986, as amended from time to time, including for such purposes, the making of distributions to organizations that qualify as exempt under such Section 501(c)3.

A new ARTICLE X.
