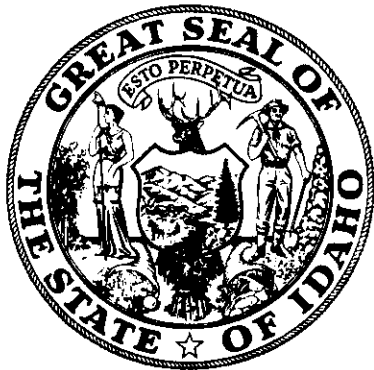

The undersigned, being a natural person of legal age, a citizen of the United States of America or its territories or possessions, and duly licensed, or otherwise legally authorized, to render professional services within the State of Idaho, has this day voluntarily presented himself for the purpose of forming a professional service corporation under the laws of the State of Idaho, and to that end hereby adopts Articles of Incorporation, as follows:

ARTICLE ONE

NAME

The name of the corporation is Seward H. French, P.A.

ARTICLE TWO

DURATION

The duration of the corporation shall be perpetual.

ARTICLE THREE

PURPOSES AND POWERS

The purposes of the corporation and its powers are the following:

1. To engage in the general practice of law.
2. To have, exercise and enjoy all purposes and powers now or hereafter granted to professional service corporations organized under the laws of the State of Idaho, and particularly all of the purposes, powers and privileges

granted to professional service corporations by Chapter 13, Title 30, Idaho Code, and present and/or future amendments thereto, and to do any act or other thing necessary or convenient for the practice of the aforesaid profession and/or carrying into effect the aforesaid purpose.

#### ARTICLE FOUR

##### STOCK

The aggregate number of shares which the corporation shall have authority to issue is 100 in number and shall be of \$1.00 par value. Said shares of stock shall be fully paid for before being issued, and after issuance shall be nonassessable.

#### ARTICLE FIVE

##### LOCATION

The location and address of the initial registered office of the corporation is 164 N. Lloyd Circle, Idaho Falls, Idaho 83401 and the name of its initial registered agent at such address is Seward H. French.


