

ARTICLES OF INCORPORATION

OF

SHAVER INVESTMENTS, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

- 1. **NAME:** The name of the corporation is SHAVER INVESTMENTS, INC.
- **2. DURATION:** The period of its duration is perpetual.
- 3. **PROFIT:** This is a profit corporation.
- 4. <u>PURPOSES</u>: The purpose or purposes for which the corporation is organized is to acquire, own and operate a Quizno's Restaurant, and do all things incidental thereto and for the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
- 5. **SHARES AUTHORIZED:** The aggregate number of shares which the corporation shall have authority to issue is 1000 shares of no par value common stock.
- 6. PRE-EMPTIVE RIGHTS: Shareholders shall have pre-emptive rights to acquire unissued or treasury stock or securities convertible into or carrying a right to subscribe to or acquire shares.
- 7. <u>BUSINESS AFFAIRS</u>: Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the corporation's By Laws, including restrictions on the transfer of shares.
- 8. REGISTERED AGENT AND OFFICE: The initial registered agent is: CAMILLE D. SHAVER, and the initial registered office is: 1356 City Creek Road, Pocatello, Idaho 83204.
- 9. <u>BOARD OF DIRECTORS</u>: There shall be no Board of Directors. Pursuant to Idaho Code §§ 30-1-801 and 30-1-732 the powers and duties conferred or imposed upon the Board of Directors by the Idaho Business Corporation Act shall be exercised or performed by the officers of the
