The name of the corporation is The Academy of Religious Science, Incorporated. - A Church.

The amendments are as follows:

- Α. Article I of the Articles of Incorporation is amended to change the name of the corporation and shall read in its entirety as follows: the name of the corporation is " The Sandpoint Sunday Service, Incorporated., A Church."
- В. Article IV (A.) is amended to read, in its entirety, as follows: This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code. The purpose of this church shall be to serve as a spiritual and religious development center to aid in the "healing of the separation between man and god", to foster spiritual, cultural and general well-being and to provide facilities for education, fellowship and public worship.

These amendments were adopted at a meeting held on December 1, 1992. A Quorum was present at such a meeting. The amendment received more than two-thirds of the votes which members present at such meeting in person or by proxy were entitled to cast.
