

The undersigned, acting as incorporator of HEARTLAND TITLE & ESCROW CO., INC., a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Heartland Title & Escrow Co., Inc.

SECOND: The period of its duration is perpetual.
