

**ARTICLES OF INCORPORATION
OF
TOM DALE MINISTRIES, INC.**

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, being natural persons of full age, citizens for the United States and residents of the State of Idaho, this day have voluntarily associated ourselves for the purpose of forming a nonprofit corporation under and pursuant to the provisions of Title 30, Chapter 3 of the Idaho Code, and we hereby certify as follows:

I.

The name of the Corporation shall be TOM DALE MINISTRIES, INC.

II.

This Corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Idaho Nonprofit Corporation Act for charitable purposes, and no part of the income of the Corporation shall be distributable to its directors or officers.

III.

The period of duration of the Corporation shall be perpetual.

IV.

The specific purpose of this Corporation is to engage in evangelistic activities designed to spread the gospel of Jesus Christ and to promote christian beliefs, values and doctrine.

V.

There shall be no membership in TOM DALE MINISTRIES INC. Directors shall be elected by the Church Board of the First Church of the Nazarene, an Idaho non-profit corporation of Nampa, Idaho.

VI.

VII.

The initial Board of Directors shall be made up of three persons. However, the number of Directors, and the manner of election or removal thereof, shall be governed by the Corporate By-Laws.

IX.

This Corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

No substantial part of the activities of this Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation and the Corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation.

The property of this Corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this Corporation shall ever insure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this Corporation shall be distributed only to a non-profit corporation, fund or foundation, to be selected by the Board of Directors, which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code.
