ARTICLES OF INCORPORATION

0F

POCATELLO CREEK DEVELOPMENT COMPANY

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, all of whom are bona fide residents of the State of Idaho and over the age of majority, do hereby associate ourselves for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify:

I.

That the name of this corporation shall be POCATELLO CREEK DEVELOPMENT COMPANY.

II.

The purposes for which this corporation is formed are as follows:

- A. To take, acquire, buy, hold, own, maintain, control, manage, develope, sell, convey, lease, mortgage, improve, subdivide, and otherwise deal in and dispose of real estate and real property or any interest and right therein.
- B. To carry on the business of developing and improving real property; to lay out for public use roads, streets, avenues or highways upon or through its lands; to extend, continue or connect all roads, streets, avenues or highways upon or through other real property to be acquired; to lay out and establish such roads, streets, avenues or highways and the extension, continuations or connections thereof; to construct drains or sewers and such bridges or culverts as may be necessary to maintain the grades of or for the extension, continuation or connection of roads, streets, avenues or highways; to construct curbing, gutters and other improvements upon said real property.

- and contractors for the purpose of building, erecting, altering, repairing or doing any other work in connection with any and all classes of buildings and improvements of homes or other structures of any kind and nature whatsoever.
- D. To purchase, lease, take, appropriate, hold, own, use, and otherwise acquire, and to maintain, own and operate water and irrigation rights and acquire, purchase, lease, take appropriate, hold, own, use and operate canals, ditches, flumes, pipelines, reservoirs, sprinkling systems, and all other works necessary and convenient for the division, transportation, and distribution and use of water for irrigation, culinary, and domestic purposes and for all other purposes for which water may be applied.
- E. To drill wells for the purpose of obtaining water for irrigation and domestic purposes. To own, maintain, and operate sprinkling systems, pumps, pipelines, canals, and irrigation ditches for the transportation, distribution, and use of water for irrigation, industrial and domestic uses and for any other purposes for which water may be applied.
- F. To purchase, hold and use from time to time as it may see fit any part of its own stock, using for such purpose any part of its surplus, but while this corporation holds the same it shall not be entitled to vote such stock or to receive dividends thereon.
- G. To purchase, hold, acquire and sell stock in any other corporation or corporations.
- H. To borrow money and execute notes and mortgages therefor, and to loan money and to take notes and mortgages to secure the repayment of same.
 - I. To do all things incedent to or connected with any

of the aforesaid purposes which might further and aid the purposes and objectives as aforesaid.

III.

The period of existence of this corporation shall be perpetual.

IV.

The location and most office address and the registered office of this corporation shall be Pocatello, Bannock County, State of Idaho.

V.

The business and prudential affairs of this corporation shall be managed by a Board of Directors. The number of Directors of the corporation shall be specified in the by-laws and such number may, from time to time, be increased or decreased in such manner as may be prescribed in the by-laws, provided that the number of the Directors of this corporation shall not be less than three (3) nor more than seven (7). The said Directors need not be stockholders of said corporation.

VI.

The amount of capital stock of this corporation shall be TWO HUNDRED THOUSAND AND NO/100 DOLLARS (\$200,000.00), divided into two thousand (2,000) shares of the par value of One Hundred Dollars (0100.00) per share.

VII.

The amount of capital stock which has actually been subscribed and paid for is Twenty-One Thousand Dollars (\$21,000.00) by the following named persons with the amount of stock of each, to-wit:
