ARTICLES OF INCORPORATION

OF

PRECIOUS LIVES CHRISTIAN HOMES FOR GIRLS INCORPORATED

I.

The name of this corporation is Precious Lives Christian Homes for Girls Incorporated.

II.

- A. This corporation is a nonprofit religious corporation and is not organized for the private gain of any person. It is organized under the Idaho Non-Profit Corporation Act for religious purposes.
- B. The specific purpose of this corporation is to operate a christian home for unwed mother-to-be, and to maintain and operate a christian home for homeless and or troubled minors.

III.

- A. This corporation is organized and operated exclusively for the religious purpose within the meaning of Section 501(c) (3) of the Internal Revenue Code.
- B. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to . influence legislation, and the corporation shall not participate or intervene in any political campaign (Including the publishing or distribution of statements) on behalf of any candidate for public office.

The property of this corporation is irrevocably dedicated to religious or charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for non-profit purposes and which has established its tax exempt status under Section 501(c) (3) of the Internal Revenue Code.
