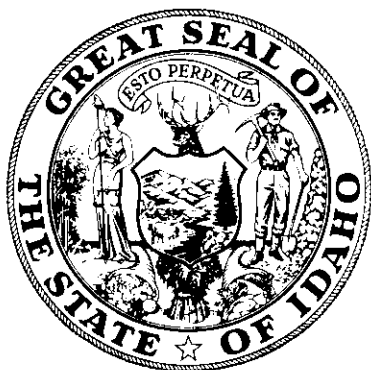

ARTICLES OF INCORPORATION
of
WESTERN SURETY MARKETING COMPANY

The following Articles of Incorporation are hereby adopted pursuant to the Idaho Business Corporation Act:

1. Name.

The name of the corporation is:

2. Duration.

The corporation shall have perpetual duration.

3. Purposes.

The corporation is formed for the purposes of manufacturing, marketing, using and leasing security valves for crude oil storage vessels and marketing of any other product which the corporation may desire to undertake, and any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
