CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

VOYAGER COOPERATIVE FLYING CLUB, INC.

was filed in the office of the Secretary of State on the **Nineteenth** day of **April**, A. D. One Thousand Nine Hundred **Sixty-three** and is duly recorded on Film No. **123** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103 and Sections 30-1001 to 30-1005, inclusive, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at **Moscow** in the County of **Latah** and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

of

"VOYAGER COOPERATIVE FLYING CLUB, INC."

I.

The name of this cooperative association is "Voyager Cooperative Flying Club, Inc.," hereinafter referred to as the "Club."

II.

The purposes for which this Club is formed are:

(a) To own or lease and maintain one or more aircraft for the pleasure, recreation and use of the members of this Club or their families or such individuals as the Board of Directors may designate pursuant to any by-laws which may hereafter be adopted.

(b) To acquire, own, hold, sell, lease, pledge, mortgage or otherwise dispose of any property, real or personal, necessary to the operation of the Club.

(c) To borrow money, contract debts, make contracts, and to exercise any and all such powers as a natural person could lawfully make, do, perform or exercise which may be necessary, convenient or expedient for the accomplishment of any of its objects or purposes, providing the same be not inconsistent with the laws of the State of Idaho and to that end, enumeration of such powers shall not be deemed inclusive.

III.

The term of existence of this Club shall be perpetual or until such time as it is dissolved as provided by the laws of the State of Idaho.

IV.

The principal office for the transaction of the business of this Club is to be located at 307 South Main Street, Moscow,

Latah County, Idaho.

V.

The same persons whose names and addresses are set forth immediately hereinabove are appointed to act as the first Directors to manage the affairs of this Club.

VII.

The Club is organized without shares.

VIII.

The property rights of the members of this Club shall be equal.

IX.

Upon the dissolution of this Club as provided by the laws of the State of Idaho, three (3) members of this Club shall be designated as trustees who shall liquidate the assets thereof and after paying all debts and liabilities of the Club, shall distribute the surplus equally among the members of said Club.


