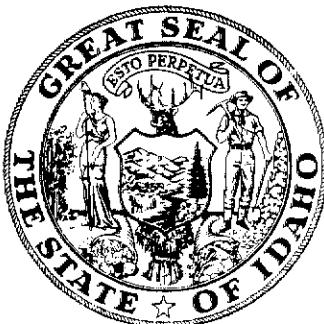

ARTICLES OF INCORPORATION
OF
QUALITY EVALUATIONS, INC.

KNOW ALL MEN BY THESE PRESENTS: That the undersigned,
acting as incorporator of a corporation under the Idaho
business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I.

The name of the corporation is Quality Evaluations, Inc.

ARTICLE II.

The objects and purposes for which this corporation are formed are: The transaction of any and all
lawful business for which corporations may be incinerated under the
Idaho Business Corporation Act.

ARTICLE III.

The corporation shall have perceptual existence.

ARTICLE IV.

The location and address of the registered office of

ARTICLE VII.

The private property of the stockholders of the corporation shall not be subject to the payment of debts to any extent whatsoever, and the shares of the corporation shall not be subject to assessment for the purpose of paying expenses, conduction business or paying debts of the corporation.

ARTICLE VIII.

The number of directors constituting the initial board of directors of the corporation is two Whose names and addresses are:

Juan and Debbie Vuittonet, 2235 S. E. 5TH Way, Meridian, Idaho 83642.

The above named persons shall serve as directors until the first annual meeting of shareholders or until successors be qualified and elected.

ARTICLE IX.

No contract or other transaction between the corporation and any other corporation and no act of the corporation shall in any way be affected or invalidated by the fact that any of the directors or shareholders of the corporation are pecuniarily or otherwise interested in or are directors or officers of such other corporation; any directors, individual or firm of which any director or shareholder may be a member, may be a party to or may be pecuniarily or otherwise interested in any contract or transaction of the corporation provided the fact that he/she or such firm so interested shall be disclosed or shall have been known to the board of directors or shareholders of the corporation which shall authorize any such contract or transaction with like force and effect as if he/she were not such officer or director of such other corporation or not so interested.

ARTICLE X.

The personal liability of a director/shareholder to the corporation or its stockholders for monetary damaged for breach of fiduciary duty as a director/shareholder is hereby eliminated and no director/shareholder shall have personal liability to the corporation or its stockholders for monetary damages for breach of fiduciary duty as directory/shareholder except that the

personal liability of a director/shareholder to the corporation for any breach of the directory/shareholder duty of loyalty to the corporation or its stockholders, for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law shall not be eliminated and the personal liability of a director/shareholder to the corporation or its stockholders for the liability imposed by Idaho Code 30-1-48 shall not be eliminated and the personal liability of a director/shareholder to the corporation or its stockholders for personal liability for any transaction from which the director/shareholder derived a legally improper personal benefit shall not be eliminated.
