Know all Men by these Presents, that we,
the undersigned, have this day volun-
tarily associated our selves together for
the purpose of forming a Corporation
under the laws of the Territory of Idaho.

And we hereby certify, First,

That the name of said Corporation
is the United Brethren Church Asso-
ciation

Second, That the purpose for
which it is formed is Religious
Worship,

Third, That the place where its prin-
cipal business is to be transacted
shall be, the town of Jamestown,
County of Latah, Idaho Territory

Fourth, That the term for which it
is to exist is fifty years from
and after the date of its incorporation

Fifth, That the number of its directors
shall be ^{five} ~~three~~ and that the names
