

1. Name. The name of the Corporation is Alyce Clegg Photography, Inc.
2. Authorized shares. The aggregate number of shares the Corporation is authorized to issue shall be one thousand (1,000), all of which shall be common voting stock.
3. Registered office and agent. The registered office of the Corporation is located at 3160 E 17<sup>th</sup> Street, Idaho Falls, ID 83406, and its registered agent at that address is Kirsten McAnulty, whose address is 3007 Westmoreland Cr, Idaho Falls, ID 83402.
4. Purpose. The purpose for which the Corporation is organized is to provide photographic services and sales.
5. Incorporators. The names of the incorporators are Kirsten McAnulty at 3160 E 17<sup>th</sup> Street, Idaho Falls, ID 83406 and Mary Broughton-Leonelli at 3160 E 17<sup>th</sup> Street, Idaho Falls, ID 83406.
6. Preemptive Rights. The Corporation elects to have preemptive rights.
7. Directors. The Corporation shall have a voting membership as defined in the corporation's bylaws. The management and affairs of the corporation shall be at all times under the operations of a Board of Directors, consisting of up to a maximum of five (5) directors, whose operations in governing the corporation shall be defined by the Idaho Professional Services Corporate Act, Idaho Code Sections 1301 et seq., and the Idaho Business Corporations Business Act, Idaho Code Sections 30-1-101 et seq. and by the corporation's bylaws. The corporation's first Board of Directors shall be comprised of the following natural person's: Kirsten McAnulty, Mary Broughton-Leonelli, Alyce Clegg and James Broughton. No member or Director shall have any right, title, or interest in or to any property of the corporations.
8. Indemnification. The Corporation shall indemnify the shareholders, officers, and directors of the Corporation to the fullest extent permitted by the Idaho Business Corporations Act, as the same exists or may hereafter be amended (but, in the case of any such amendment, only to the extent that such amendment permits the Corporation to provide broader indemnification rights than the Idaho Business Corporation Act permitted the Corporation to provide prior to such amendment).
