The undersigned, Foy Brown, Clarence L. Fritts, Earl Boston, and Cecil Evans, Trustees of the First Methodist Episcopal Church of Apple Valley, an Idaho Corporation, do hereby certify and respectfully represent as follows:

That on May 5, 1970, a special meeting of the Trustees and members of the First Methodist Episcopal Church of Apple Valley, was held pursuant to a public notice for the purpose of voting on an amendment to the Articles of Incorporation to provide for perpetual existence of the corporation. AT that meeting the following resolution to amend the Articles of Incorporation was unanimously adopted by over two-thirds of the voting power of all members present and voting.

Resolved that Article Three of the Articles of Incorporation be amended to read as follows:

ARTICLE THREE

The term of this corporation shall be perpetual.
