ARTICLE I.

Name

Duration

The period of duration of this corporation is perpetual.

Preemptive Rights

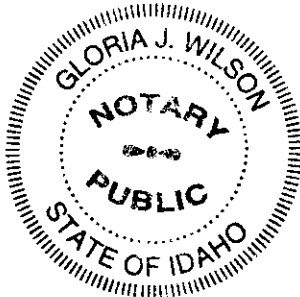
