## ARTICLES OF INCORPORATION $\mathbf{H}(\mathbf{r})$ LINDS AY OF MAGIC VALLEY CO.

## KNOW ALL MEE BY THESE PRESENTS:

all being full-age citizens of the United States, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end do hereby adopt articles of incorporation as follows:

#### ARTICLE I.

The name of the proposed corporation is LINDSAN OF MAGIC VALLEY CO.

#### ARTICLE II.

The names, residences and post office addresses of the corporators are as follows:

	ARTICLE III.	

The principal place of business of this corporation shall be in the County of Twin Falls, State of Idaho.

#### ARTICLE IV.

The nature of the business of the corporation and the objects or purposes proposed to be transacted, promoted, or carried on by it, are as follows, to-wit:

- a. To engage in buying, selling, manufacturing, leasing, renting, repairing, servicing of water softeners and other devices in the treatment of water.
- To engage in the buying and selling and manufacturing of plumbing supplies of every kind, nature, and description, both domestic and industrial, and in the buying and selling of all building supplies and equipment of any kind,

nature, or description whatsoever.

- c. To buy, sell, lease, rent, prepare, service, treat, experiment, invent, patent, manufacture, and generally deal in and with chemicals, chemical compounds, chemical preparations, secret processes, and mixtures of any and all kinds to be used in plumbing or any other kind of business.
- d. To engage in the carrying on of a general business of manufacturing and selling of electrical and mechanical products, equipment, parts, devices, instruments, specialty products, including research, development, designing, maintenance, repairing, and conversion of electrical and mechanical products.
- e. To purchase, lease, or otherwise acquire such grounds, real estate, and buildings as this corporation may need for storage, warehousing, office, factory space, or for any other purpose in carrying on this purpose.
- f. To do all things incidental to and necessary for the carrying on of a rental, sales, and service business in water softeners, including the financing and monetary transactions incidental thereto.

## ARTICLE V.

The authorized amount of capital stock of this corporation shall be Five Thousand and no/100 (\$5,000.00) Dollars, divided into Five Thousand (5,000) shares having a par value of One and no/100 (\$1.00) Dollar each. Said capital stock shall be paid in at such times and upon such conditions as the Board of Directors may by resolution direct, either in cash, or by services rendered to the corporation, or by real or personal property transferred to it. Shares of stock when issued in exchange for services or property pursuant to a resolution of the Board of Directors shall thereupon become and be fully paid up the same as though paid for in cash at par, and shall be nonassessable forever, and the determination of the Board of Directors as to the value of any

property or services received by the corporation in exchange for stock shall be conclusive.

#### ARTICLE VI.

The time of the commencement of this corporation shall be the date of the issuance to it of a certificate of incorporation by the Secretary of State of the State of Idaho, and the time of its termination shall be fifty (50) years from and after said date, with the privilege of renewal in the manner provided by law.

### ARTICLE VII.

The affairs of this corporation shall be conducted by a board of three (3) directors who shall be stockholders of the corporation, and by such officers as the said Board of Directors may from time to time elect or appoint. Said directors shall be elected annually by the stockholders at the meeting held on the first Monday of January of each year, provided, however, that if that day shall be a holiday, then the following day; and shall hold office until their successors are elected and have qualified. Until the first have qualified, the following named persons shall serve as directors of this corporation, to-wit:
