Section 1: The name of the organization shall be the
NORTH IDAHO AIDS COALITION, Incorporated.

ARTICLE II

Section 1: The NORTH IDAHO AIDS COALITION, Inc.(NIAC),
is a non-profit community service organization providing
supportive services to those affected by, and prevention
efforts to stop the transmission of, the human
immunodeficiency virus (HIV), the virus that causes AIDS.
NORTH IDAHO AIDS COALITION provides financial, psychosocial,
supportive and spiritual assistance for individuals with HIV
infection and their families. All services are delivered
without regard to age, race, color, national origin, sex,
sexual orientation, or religious preference. The emphasis
of service is on quality of life, client self determination
and dignity.

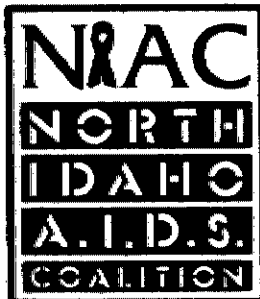
