ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 30-327, of the Idaho Nonprofit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Sun Valley-Ketchum Chamber of Commerce, Inc.

2. The Articles of Incorporation are hereby amended by deleting the references to Section 501(c)(3) of the Internal Revenue Code of 1951 in Articles IV, IX and X and replacing the same with Section 501(c)(6) of the Internal Revenue Code of 1951.

3. The date of the meeting of members at which the foregoing amendment was adopted was June 30, 1983. A quorum was present at such meeting and such amendment received a majority of the votes which members present at such meeting in person or by proxy were entitled to cast.
