ARTICLES OF INCORPORATION
OF

ARTICLE I
NAME

The name of the corporation is Sand Hollow Development Co. (the "Corporation").

ARTICLE II
AUTHORIZED SHARES

The Corporation shall be authorized to issue 10,000 shares of common stock having no par value.

ARTICLE III
BOARD OF DIRECTORS

All corporate powers shall be exercised by or under the authority of, and the business and affairs of the Corporation managed under the direction of, its board of directors, subject to any limitation set forth in a shareholder agreement authorized under section 30-1-732 of the Idaho Business Corporation Act (the "Act"). The number of directors constituting the initial board of directors shall be two, and the name and address of the individual to serve as the initial director until the first annual meeting of shareholders or until his successor is elected and qualified is:

ARTICLE IV
INDEMNIFICATION

The Corporation shall indemnify the directors and officers of the Corporation to the fullest extent permitted by the Act, as the same exists or may hereafter be amended (but, in the case of any such amendment, only to the extent that such amendment permits the Corporation to provide broader indemnification rights than the Act permitted the Corporation to provide prior to such amendment).

**ARTICLE V
LIMITATION OF LIABILITY**

No director shall be liable to the Corporation or its shareholders for monetary damages for breach of fiduciary duty except liability for: (i) the amount of a financial benefit received by a director to which he is not entitled; (ii) an intentional infliction of harm on the Corporation or the shareholders; (iii) a violation of section 30-1-833 of the Act; or (iv) an intentional violation of criminal law.

**ARTICLE VI

**ARTICLE VII
