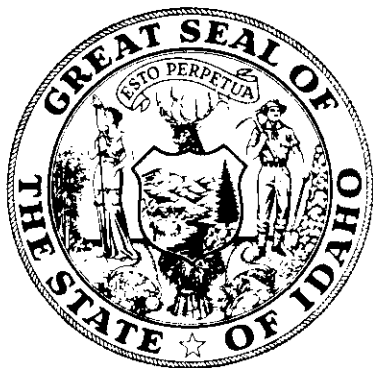

BE IT KNOWN, that we, the undersigned, President and Secretary, do hereby certify in accordance with the provisions of Section 30-146, Idaho Code, as follows:

1. That a special meeting of all of the shareholders of the issued and outstanding stock of WARM SPRINGS CHILDREN'S CLINIC, P.A., was held at the offices of the corporation at 100 Warm Springs Avenue, Boise, Idaho at 12:00 o'clock p.m., on the 7th day of October, 1985, pursuant to call and waiver of notice and consent, at which meeting all of the issued and outstanding common stock was represented in person or by proxy.

2. That at said meeting, the following resolution was submitted, and upon being put to a vote was unanimously adopted by the unanimous vote of all of the issued, and outstanding capital stock of the corporation, to wit:

BE IT RESOLVED that Article I of the Articles of Incorporation of WARM SPRINGS CHILDREN'S CLINIC, P.A., be amended by deleting the entire Article I and inserting in place of it the following Article I:

ARTICLE I.

The name of the corporation shall be TREASURE VALLEY PEDIATRICS, P.A.




