

ARTICLES OF INCORPORATION

CAMAS PRAIRIE PORK ASSOCIATES, INC.

WE, the undersigned, do hereby form a non-profit corporation, Chapter 3, Title 30 of the Idaho Code, and do hereby certify and declare:

ARTICLE I: NAME The name of this organization shall be the CAMAS PRAIRIE PORK ASSOCIATES, INC.

ARTICLE II: NONPROFIT, EXISTENCE This corporation is organized as a cooperative marketing association, a non-profit corporation of the State of Idaho, and its length of existence shall be perpetual.

ARTICLE III: PURPOSE The purposes of this corporation is formed without pecuniary interest are to promote, conduct, provide for and carry on any and all activities in connection with the operation of a community grange for the benefit and general welfare of the citizens of the community of Cottonwood, Idaho County, Idaho and the surrounding environs. The Corporation shall have the power to do anything not prohibited by law necessary or requisite for the furthering of the purposes of this corporation.

ARTICLE IV: MEMBERSHIP The corporation shall not have nor issue any capital stock, but shall issue membership certificates to each member and all the rights and interest of each member shall be equal and no member may have or acquire a greater interest than any other member therein. The corporation shall have the power to admit new members who shall be entitled to share in the property of the association with the old members, in accordance with the foregoing general rule.

ARTICLE V: REGISTERED AGENT AND ADDRESS Registered agent shall be Michael L. Crea. The location and street address of the corporation's initial registered office shall be 807 North St, POB 44, Cottonwood, Idaho 83522,
