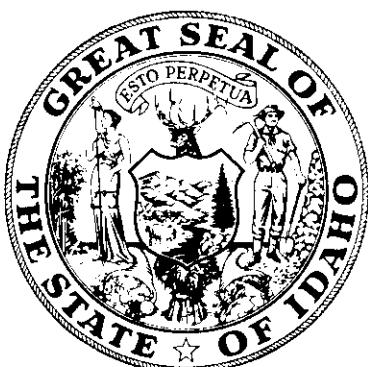

ARTICLES OF INCORPORATION  
OF  
BUILDING DEPARTMENT, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

The name of the Corporation shall be BUILDING DEPARTMENT, INC.

ARTICLE II

TERM

The period of its duration is perpetual.

ARTICLE III

PURPOSE

The purpose for which this Corporation is organized is to conduct and carry on a general business to provide professional building services to individuals, cities, and counties and to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

## ARTICLE IV

### SHARES

The aggregate number of shares which the Corporation shall have authority to issue is: Five Hundred (500) at \$1.00 par value.

## ARTICLE V

### PREEMITIVE RIGHTS

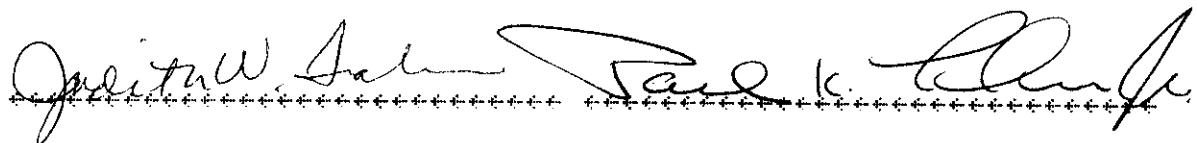
