I.

The name of this corporation is TRADE DOLLAR LEASING COMPANY.

II.

The period of the existence of this corporation shall be fifty (50) years.

III.

The principal effice and the place where the principal business of said corporation is to be transacted is at the City of Roise, County of Ada, State of Idaho.

IV.

The purposes for which this corporation is formed are as follows:

To lease, acquire, own, work, mortgage, sell and dispose of mines, mining grounds, lode or placer claims, mills, mill sites, tunnel sites, mining and mineral rights, and any interest therein, and to prospect, explore, work, locate, develop and turn to account the same.
