ARTICLES OF INCORPORATION
OF THE
ALAMEDA ELECTRIC, PLUMBING & HEATING CO.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, being natural persons of full age and citizens of the United States, in order to form a corporation for the purposes hereinafter stated, pursuant to the Business Corporation Act of Idaho do hereby certify as follows:

I.

The name of the corporation is ALAMEDA ELECTRIC, PLUMBING AND HEATING COMPANY.

II.

The purposes for which said corporation is formed are:

To do electrical, plumbing and heating contracting and to merchandise and sell, both wholesale and retail, all materials, equipment or appliances thereto pertaining. To repair, rebuild or service any equipment, machinery or installation in the electrical, plumbing, and/or heating fields. To purchase, or otherwise acquire, real and/or personal property of every kind and description within and without the State of Idaho, and to convey, sell, assign, transfer, lease, mortgage, pledge, exchange or otherwise dispose of any of such property. In general, to carry on any other operation in connection with the foregoing, and to have and exercise all of the powers conferred by the laws of the State of Idaho upon corporations formed under the Act herein referred to and to do any or all of the things hereinbefore set forth to the same extent as natural persons might or could do.

It is the intention that the objects, purposes, and powers specified in this section shall, except where otherwise specified, be no wise limited or restricted by reference to or inference from the terms of any clause or paragraph used herein. In general, said corporation shall have and exercise all the powers conferred by the laws of the State of Idaho on this type of business corporation, it being hereby expressly provided that any enumeration of

specific powers herein shall not be held to limit or restrict in any manner such general powers.

III.

The corporation is to have perpetual existence.

IV.

The location and post office address of the registered office of the corporation is 120 East Walnut, Alameda, Bannock County, Idaho.

V.

The total authorized number of par value shares is 250 shares of the par value of \$100 per share.

VI.
