

ARTICLES OF INCORPORATION

OF

MR. A'S DRY CLEANERS, INC.

SL 17 10/25/1971

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is MR. A'S DRY CLEANERS, INC..

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 5,000. *per Deanne Thompson* *no par value*

FIFTH: The address of the initial registered office of the corporation is 525 Sunrise Blvd. North, Twin Falls, Idaho 83301, and the name of its initial registered agent at such address is Blaine C. Anderson.


