ARTICLES OF INCORPORATION

The undersigned, being a duly licensed attorney at law qualified to practice law pursuant to the laws of the State of Idaho, for the purpose of forming a professional corporation under the "Professional Service Corporation Act" of the State of Idaho, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is GLEN G. UTZMAN, CHARTERED.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the rendering of professional services of law and engaging in the practice of law in the State of Idaho and the transaction of any or all lawful business for which such corporation may be incorporated under the Idaho Professional Service Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 5,000 shares, such

shares to consist of one class only and shall have a par value of ONE DOLLER (\$1.00) for each share.

The aggregate par value shall be \$5,000.00.

No shares may be issued to anyone other than an individual who is duly licensed or otherwise legally authorized by the State of Idaho to render professional services of an attorney at law, as provided by the Idaho Professional Service Corporation Act.

No person can continue to hold shares except as provided under the provisions of the Idaho Professional Service Corporation Act, and the by-laws of the Corporation.

FIFTH: No shareholder may sell or transfer his shares in the Corporation except as provided by the Idaho Professional Corporation Act, provided, however, the board of directors may adopt by-laws restraining the alienation of shares and providing for the purchase or redemption by the corporation of the shares, as provided by the Idaho Professional Corporation Act.

SIXTH: The address of the initial registered office of the corporation is P.O. Box 8477, 1004 Nez Perce Street, Moscow, Idaho 83843, and the name of its initial registered agent at such address is Glen G. Utzman.

SEVENTH: The number of directors constituting the initial board of directors of the corporation is one, and the name and addresse of the person who is to serve as director until the first annual meeting of shareholders or until his successor is elected and shall qualify is;




