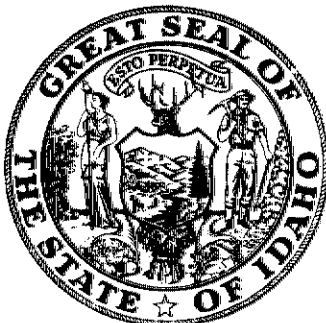

- FIRST: The name of the corporation is Sassy, Inc.
- SECOND: The period of its duration is perpetual.




