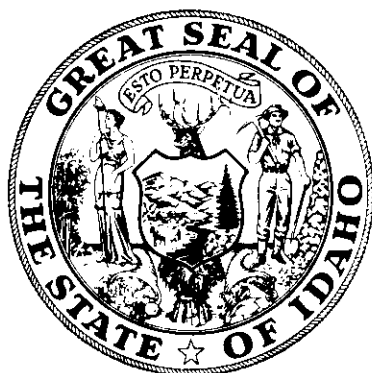

ARTICLES OF AMENDMENT
TO
THE ARTICLES OF INCORPORATION
OF
GeoBon, Inc.
(Nine, Inc.)

Pursuant to the Provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

First: The present name of the corporation is GeoBon, Inc.

Second: The following Amendment of the Articles of Incorporation were adopted by the shareholders of the corporation on the 31st day of January, 1986, in the manner prescribed by the Idaho Business Corporation Act: That Article 1, be and same is hereby amended to read as follows:

1. The name of the corporation is Nine, Inc.

Third: The number of shares the corporation outstanding at the time of such adoption was 100 shares and the number of shares entitled to both thereon was 100 shares.

Fourth: The number of shares voted for such amendment was 100; and the number of shares voted against such amendment was zero (0).


Fifth: The manner in which any exchange, reclassification or cancellation of any shares provided for in the amendment shall be affected as follows: Old stock certificates bearing the name Geo Bon, Inc., shall be exchanged by all stock holders for new stock certificates bearing the name of Nine, Inc.


Sixth: The manner in which such amendment effects a change in the amount of stated capital, and the amount of stated capital as changed in such amendment, are as follows: This amendment shall have no effect on stated capital.

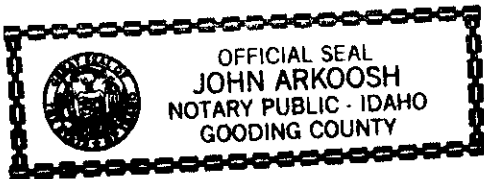

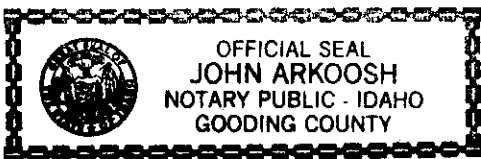
