ARTICLES OF INCORPORATION OF NORTHWEST FENCE COMPANY, INC.

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following ARTICLES OF INCORPORATION for such corporation:

ARTICLE I

THE NAME of the corporation is NORTHWEST FENCE COMPANY, INC.

ARTICLE II

THE PERIOD OF THE corporation's duration is perpetual.

ARTICLE III

THE PURPOSE for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

THE AGGREGATE NUMBER of shares which the corporation shall have authority to issue is ONE THOUSAND SHARES, with a par value of ONE DOLLAR (\$1.00) common stock.
