KNOW ALL MEN BY THESE PRESENTS, that we the undersigned have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

And we hereby certify:-

I

That the name of said corporation is Waverly Mining Company.

II.

That the purposes for which it is formed are to carry on the business of mining for gold, silver and other minerals, working and operating mines, milling and smelting the ores and products thereof, buying and selling mining property of all kinds and to do any and all things connected therewith in the county and State of Idaho.

III.

That the place where its principle business is to be transacted shall be in the city of Moscow County of Latah and State of Idaho.

IV.

That the term for which it is to exist is fifty years from and after the date of its incorporation.

V.

That the number of its directors shall be five and that the names and residences of those who are appointed for the first year are:
