ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is ROSTISLAV'S CUSTOM FURNITURE & DESIGN, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

1. To engage in the business of designing, building and manufacturing custom furniture, cabinets, wooden decorating items, and doing all types of woodwork.

2. To transact any and all lawful business for which corporations may be incorporated under the laws of the State of Idaho.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is One Hundred Thousand (100,000) shares of the par value of One Dollar (\$1.00).

FIFTH: The address of the initial registered office of the corporation is 607 Lawrence Avenue, Boise, Idaho 83709, and the name of its initial registered agent at such address is Rostislav Vachek.




