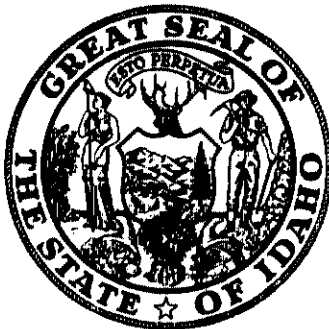
### CERTIFICATE OF INCORPORATION OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:


- FIRST:** The name of the corporation is: LAMPERT FARM & RANCH, INC..
- SECOND:** The period of its duration is perpetual.
- THIRD:** The purpose or purposes for which the corporation is organized are: The transaction of a business and any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
- FOURTH:** The aggregate number of shares which the corporation shall have authority to issue is 100,000. The shares shall have no par value.


