ARTICLES OF INCORPORATION
OF
CHRISTY MANUFACTURING, INC.

2 We, the undersigned, being adult citizens of the
3 United States of America, do hereby associate ourselves for
4 the purpose of forming a corporation pursuant to Chapter 1
5 of Title 30, Idaho Code, and we do hereby adopt and certify
6 the following Articles of Incorporation, towit:

7 ARTICLE I

8 The name of this Corporation shall be "CHRISTY MANUFAC-
9 TURING, INC."

10 ARTICLE II

11 The term of existence of this corporation shall be
12 perpetual.

13 ARTICLE III

14 The purposes for which this corporation is organized
15 are the transactions of any and all lawful businesses for
16 which corporations may be incorporated under this act.

17 ARTICLE IV

18 The aggregate number of shares of which the corporation
19 shall have the authority to issue is Five Thousand (5,000),
20 consisting of one (1) class only. The par value of each share
21 shall be the sum of One Dollar (\$1.00). The total authorized
22 capital stock of the corporation is the sum of Five Thousand
23 Dollars (\$5,000.00). The stock of this corporation shall be
24 nonassessible.

25 ARTICLE V

26 The address of the initial registered office of the
27 corporation is P.O. Box 1356, Orofino, Idaho 83544. The name
28 of the initial registered agent of the corporation at the
29 initial registered office of the corporation is W. David Gladhart.

The corporation shall have three (3) directors, except in the event that all of the shares of the corporation are owned beneficially and of record by fewer than three (3) shareholders, in which event the number of directors may be fewer than three (3) but not fewer than the number of shareholders.
