#### ARTICLES OF INCORPORATION

OF

#### CHRISTY MANUFACTURING, INC.

We, the undersigned, being adult citizens of the
United States of America, do hereby associate ourselves for
the purpose of forming a corporation pursuant to Chapter 1
of Title 30, Idaho Code, and we do hereby adopt and certify
the following Articles of Incorporation, towit:

## ARTICLE I

The name of this Corporation shall be "CHRISTY MANUFACTURING, INC."

# ARTICLE II

The term of existence of this corporation shall be perpetual.

### ARTICLE III

The purposes for which this corporation is organized are the transactions of any and all lawful businesses for which corporations may be incorporated under this act.

#### ARTICLE IV

The aggregate number of shares of which the corporation shall have the authority to issue is Five Thousand (5,000), consisting of one (1) class only. The par value of each share shall be the sum of One Dollar (\$1.00). The total authorized capital stock of the corporation is the sum of Five Thousand Dollars (\$5,000.00). The stock of this corporation shall be nonassessible.

#### ARTICLE V

The address of the initial registered office of the corporation is P.O. Box 1356, Orofino, Idaho 83544. The name of the initial registered agent of the corporation at the initial registered office of the corporation is W. David Gladhart. The mailing address of the office of the corporation is P.O. Box 1356, Orofino, Idaho 83544.

## ARTICLE VI

The corporation shall have three (3) directors, except in the event that all of the shares of the corporation are owned beneficially and of record by fewer than three (3) shareholders, in which event the number of directors may be fewer than three (3) but not fewer than the number of shareholders.

The initial Board of Directors shall consist of two
