

Certificate of Incorporation
of
The Snake River Water Company

Art. I.

This certifies that we the undersigned
have this day formed a Company
for the purposes hereinafter specified
and which shall be known as the
Snake River Water Company, with such
powers and franchises as are allowed
Corporations by Law.

Art. II.

The object for which this Corporation
is formed is to take the water of
South Fork of Snake River in Custer
County, Idaho and convey same by Canal
and lateral ditches to lands upon the
lands of Snake River Valley for the
purposes of disposing of same for
Agricultural, Transportation, Mining
Mechanical and other purposes - to
purchase and hold Real Estate
so far as may be necessary for the
purposes of the Corporation and
not exceeding the amount allowed by
law and to sell and convey the same.

Art. III

The principal place of business of said Corporation shall be at Eagle Rock, Oneida County, Idaho Territory and where the offices of the Company shall be kept.

Art. IV.

The Capital stock of said Corporation shall be Thirty Thousand Dollars (\$30,000.) divided into three hundred shares of One Hundred Dollars Each which shall forever remain unassessable unless otherwise voted by a unanimous vote of all the Stockholders.

Art. V.

The term of existence of said Corporation shall be fifty years from the date hereof.

Art VI.

The number of Trustees of said Corporation shall be four and the names and residences of those who shall manage the concerns of the Company for the first three months are as follows:
