

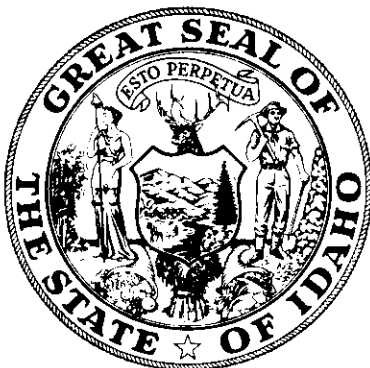


AMENDED CERTIFICATE OF AUTHORITY



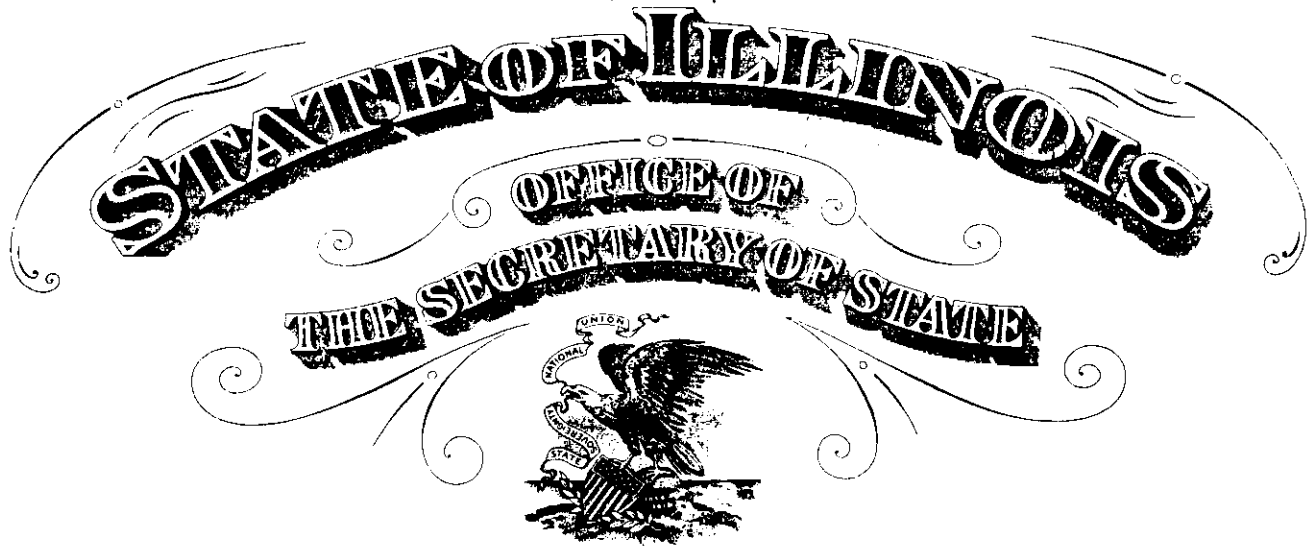
