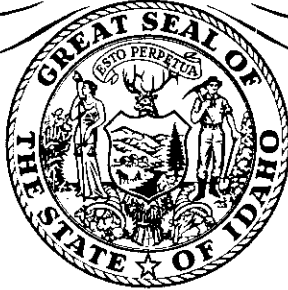

### CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the

#### **CILEX, INC.**

a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the **Seventh** day of **January**, 19 **63**, original articles of amendment, as provided by Section **s 30-146, 30-147, and 30-149, Idaho Code, amending ARTICLE V decreasing capital stock to \$50,000.00 divided into 500 shares Common Stock, at the par value of \$100.00 per share,**

and that the said articles of amendment contain the statement of facts required by law, and are recorded on Film No. **122** of Record of Domestic Corporations of the State of Idaho.

I THEREFORE FURTHER CERTIFY, That the Articles of Incorporation have been amended accordingly.

CERTIFICATE OF AMENDMENT OF  
ARTICLES OF INCORPORATION OF  
CILEK, INC.,

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, the President and Secretary respectively, of Cilek, Inc. do hereby certify as follows:

That Cilek, Inc., is a corporation duly organized and existing under and by virtue of the laws of the State of Idaho; that a special meeting of the shareholders of said corporation was duly held on the 15th day of December, 1962, in the City of Twin Falls, County of Twin Falls, State of Idaho, at which meeting all of the shareholders of said corporation were present either in person or by proxy; that notice in writing of said meeting was duly given to all shareholders according to law, more than 30 days prior to said meeting and which notice set forth that the following resolution was to be presented to the shareholders at said meeting:

"BE IT RESOLVED that the Articles of Incorporation of Cilek, Inc. be amended by amending Paragraph V. so that it shall, as amended, read as follows:

IV.

That the amount of the authorized stock of said corporation shall be Fifty Thousand Dollars (\$50,000.00), divided into five hundred (500) shares of common stock, at the par value of One Hundred Dollars (\$100.00) each.' "

That at said meeting of shareholders on December 15, 1962, the above resolution was regularly proposed, voted upon, and adopted by the unanimous vote of all of the shareholders of said corporation.

That the total number of shares of the corporation previously authorized was 1,000 shares of common stock at a par value of \$100.00 each being a total authorized capital stock of \$100,000.00; that by reason of said amendment the total number of share, including those previously authorized, which the corporation will thenceforth be authorized to have will be 500 shares of common stock of a par value of \$100.00 each, being a total authorized capital stock of \$50,000.00.

That Paragraph V. of the Articles of Incorporation of Cilek, Inc. has thereby been amended so that, as amended, it reads as follows:

"V.

That the amount of the authorized stock of said corporation shall be Fifty Thousand Dollars (\$50,000.00), divided into five hundred (500) shares of common stock, at the par value of One Hundred Dollars (\$100.00) each."
