## ARTICLES OF INCORPORATION OF

GLO, INC.

90 FEB 26 AM 10 29

The undersigned incorporators, acting pursuant to the provisions of the Idaho Business Corporation Act, adopt the following Articles of Incorporation for their new corporation.

ARTICLE ONE: The name of the corporation is GLO, INC.

ARTICLE TWO: The period of duration of the corporation is perpetual.

ARTICLE THREE: The purposes of the corporation are:

(1) To develop, manufacture, market, and sell a new product, and

(2) To engage in any and all lawful business for which a corporation may be organized under the Idaho Business Corporation

Act.

ARTICLE FOUR: The total number of authorized shares that the corporation shall have is Ten Thousand (10,000), which shares shall be without par value.

ARTICLE FIVE: There will be only one class of shares.

ARTICLE SIX: The preemptive rights of the shareholders are not to be denied.

ARTICLE SEVEN: There are no provisions for the regulation of the internal affairs of the corporation.
