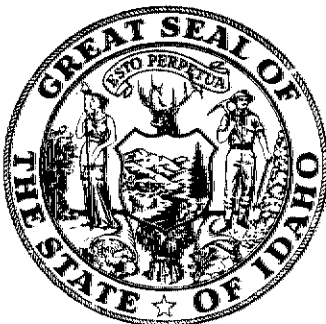

SECRET STATE

I.

The name of the corporation is DISTRIBUTED DATABASE CONSULTING, INC.

II.

The period of its duration is perpetual.

III.
