98 Mar 30 AH 10:53 The undersigned, all citizens of the United States, desiring to form a Non-Profit under the Non-Profit Corporation Act of the State of Idaho, do hereby certify:

ONE: The name of the Corporation shall be Island Park Library Friends, Inc.

TWO: The place in this state where the principal office of the corporation is to be located is in Fremont County.

THREE: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under Title 30 Chapter 3 of the Idaho Code for charitable purposes. The specific purposes for which this corporation is organized are to establish a charitable membership institution which will make available for people of all ages, materials which have educational value and provide enjoyment and through the promotion and maintenance of special collections. These purposes are to be furthered by working with the library for Island Park.

Island Park is defined as that area in northern Fremont County from Pinehaven in the south to the Montana border, east and west of U. S. 20.

FOUR: The name and address in the state of Idaho of this corporation's initial registered agent for service of process is Genevieve Prahasto, P O Box 110, Macks Inn, ID 83433.

FIVE: (a). This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code.

- (b). Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 ( c ) (2) of the Internal Revenue Code.
- (c). No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.
